**CHARACTERISTICS OF THE EDUCATIONAL PROGRAM**

The program is aimed at training highly qualified specialists with competencies in the field of accounting, financial and managerial accounting, tax accounting, internal control and external audit, comprehensive analysis of financial and economic activities of an economic entity, taking into account the main trends in the development of these areas of practical activity in Russia and abroad in accordance with the requirements of educational standards, employers, professional organizations.

From the standpoint of a professional approach, the main direct result of educational activity is the formation of key competencies, which are formed on the basis of active and interactive forms of conducting training sessions (master classes conducted by leading auditors, financial managers of large enterprises in Yekaterinburg and Russia).
