CHARACTERISTIC OF THE PROFILE

The goal of the program: training a new generation of professional managers who know the modern methodology of company management, based on the formation and development of strategic thinking

Main educational results: during their studies, students develop an integrated strategic approach to managing companies in the face of risk and uncertainty of Russian business, as well as develop the skills of conducting applied scientific and analytical research to improve the efficiency of specific business structures. The complex of knowledge, skills and competencies is aimed at ensuring the readiness of graduates to carry out professional management activities in the field of corporate management, aimed at developing and implementing a strategic management system and carrying out structural changes.

BENEFITS OF THE PROGRAM

The master's program is implemented by two departments of the university - the Department of Management and Entrepreneurship in conjunction with the Department of Economic Theory and Corporate Governance, which makes it interdepartmental, unique, practice-oriented, formed in accordance with international and national standards in the field of strategic and project management. A highly qualified teaching staff is involved in the master's program, including project management specialists (IPMA, PM STANDARD), practitioners and analysts. All faculty members involved in the program have doctorate and Ph.D. degrees, practical experience in business consulting, and are well

versed in business needs.

Departments - holders of the program - cooperate with a large number of organizations on the basis of which students can practice and conduct scientific research.

The Department of Management and Entrepreneurship cooperates with enterprises of various industries, the Sverdlovsk Regional Union of Industrialists and Entrepreneurs, the Ural Chamber of Commerce and Industry, the Fund for Technological Development of Industry of the Sverdlovsk Region and other organizations, as well as with a number of executive government bodies, including the Ministry of Investment and Development of the Sverdlovsk region, the Ministry of Industry and Science of the Sverdlovsk region.

The Department of Corporate Economics and Business Management actively interacts with the National Association for Project Management "SOVNET". On the basis of the department, the Regional Center for Assessment and Development of Project Management was opened. The peculiarity and competitive advantage of this master's program is that graduates have the opportunity to obtain a Russian certificate of project manager according to the PM STANDARD version. The department actively cooperates with foreign partners: Warsaw School of Economics (Poland), Business School of Luiss University of Rome (Italy), England Ruskin University (Great Britain), etc.

Features of the program implementation - the optimal combination of research apparatus with applied technologies in strategic and project management, taking into account the best world and domestic practices in studying the functional areas of companies' activities and information technologies, developed on the basis of real situations. Classes are held in the form of multimedia presentations, trainings, case studies, round tables, work-shop studies, participation in scientific and practical events. Graduates who have shown aptitude for scientific research can continue their studies in the postgraduate study of USUE in the scientific specialty 08.00.05. "Economics and National Economy Management".
