Know: the basic laws of the socio-economic development of the Russian Federation, its regions and municipalities; mechanisms, methods and tools for regulating the economy and economic development of territories, regional and local markets, business entities; theoretical-methodological and legal aspects of the development and analysis of regional and municipal programs, projects, strategic planning documents; key aspects of investment policy and methods of investment analysis; principles of project financing and public-private partnership; economic and legal foundations of state property management in the complex; the concept and methods of budgetary regulation.

Be able to: make organizational and managerial decisions and develop measures aimed at promoting the economic development of territories, regional and local markets, business entities, overcoming negative trends and problems; develop and apply design and strategic solutions in the economy at micro- and meso-levels, assess their economic and social efficiency; examine the projects in the field of investment the first activity; make decisions and develop measures aimed at improving the efficiency of management and disposal of property owned by the region, municipality; analyze the effectiveness of budgetary policy and develop directions for its improvement.

Have practical experience: application of mechanisms, methods and tools for regulating the economy and economic development of territories, regional and local markets, business entities; development and diagnostics of programs, projects, strategic planning documents; collecting and analyzing data necessary for evaluating and making investment decisions; preparation and justification of proposals to improve the efficiency of management and disposal of property owned by the region, municipality; evaluating the results and prospects of budgetary policy at the regional and municipal levels.
